## **The Ryan Woodward Memorial Business Scholarship Application**

- Applicant must provide a personal statement with the scholarship application including the following information:
  - Brief description of the applicant's personal aspirations and educational goals.
  - Personal/Academic Achievements.
  - Community involvement/other activities.
  - Work experience (if any) and how working has effected your current aspirations.
- Applicant must **submit one letter of recommendation** from the applicant's teacher, counselor or mentor.
- Applicant must be a senior at Grand Ledge High School.
- Immediate family members of the Ryan Woodward Memorial Fund Board of Directors are not eligible for scholarship consideration.
- Funds will be available for college level courses or other appropriate or qualified courses. The scholarship monetary award shall be payable to the college you will attend. Should the winner not enroll within one year of the date of the scholarship award; the scholarship will be forfeited and the funds will be returned to the Ryan Woodward Memorial Scholarship Fund.
- **Applications must be US postmarked by April 30, 2020. Any application postmarked after that date will be disqualified.**
- Student will receive an application acknowledgement via email.
- The Scholarship winner(s) will be notified in May.
- The Scholarship winner(s) will be recognized at the Grand Ledge High School Honor's Ceremony.
- The number and amount of scholarships awarded annually varies depending on the number of applicants and the amount of funds available in the Ryan Woodward Memorial Fund.
- The determination of the scholarship recipient(s) will be the sole discretion of the Ryan Woodward Memorial Fund Board of Directors.
